REPORT OF SEVENTEENTH BIENNIAL SESSION OF THE UNITED GRAND CHAPTER OF AUSTRALIA IN ADELAIDE, SOUTH AUSTRALIA ON 6 – 9 JUNE 2019

The Seventeenth Biennial Session of The United Grand Chapter of Australia (UGCA) was held in Adelaide, South Australia from 6 - 9 June 2019.

Attendances were down compared with previous Sessions - There were a total of 204 registrations including Overseas Members. There were 44 Non-Members and 17 Invited Guests with a total of 265 people at the Open Installation. Other details are - Formal Opening 207; Business Session 137; Grand Representatives' Lunch 141; Formal Dinner 170; Friday Lunch 131; and Installation Banquet 250.

The Formal Opening was held on Thursday, 8 June 2019. Sister Susan Cameron filled the position of the Yellow Ray of Ruth.

Brother Michael Cornell, Ambassador of the General Grand Chapter to Australia was presented in the West for introduction, welcomed and escorted to the East.

Other Australian and Overseas Distinguished Members were introduced and extended Grand Honours or welcomed by acclamation.

The Worthy Grand Secretary read the Roll of Distinguished and Honorary Members who had been called Home during the Biennium then Sister Helen McLaughlan Most Worthy Grand Matron (MWGM) signed the names of those Members in the United Grand Chapter Bible.

Brother Michael Cornell was escorted to the Altar. Brother Michael Struthers Most Worthy Grand Patron (MWGP) conferred Honorary Membership on our Distinguished Member, who was presented with his Honorary Member Diploma.

The MWGM was assisted by the Heads of the State Governing Levels in recognising the service given by her chosen Star Points.

Sister Elizabeth Watt PMWGM Immediate Past President, Sister Margaret Smith Secretary/Treasurer and Brother Graham Deacon Worthy Grand Fraternal Correspondent introduced the Grand Representatives in attendance and presented the Grand Representatives' Service.

Apologies for Absence were read and received.

The United Grand Chapter proceeded to continue with the business as per the programme for the Business Session on Friday, 7 June 2019.

Minutes of the Sixteenth Biennial Session in Perth Western Australia on 8, 9 and 10 June 2017, Special Session in Sydney on 15 March 2018, various Committees and Questions by Correspondence were moved, seconded and carried.

The Audit Report. Financial Statement and Balance Sheet were received and Dennis K Wright & Associates, Kurunjang, Victoria will be the Auditor for all United Grand Chapter Accounts for the ensuing term.

Correspondence was received and dealt with.

Recommendations from Committees were received, moved, seconded and carried.

- Covers for the Constitution & Laws will now be white including a white insert with a coloured logo and the inserts will be printed as they are required.
- It was agreed that clothing items be allowed to be sold from the kits.
- ♦ The Shopfront on the Website is up and running and Brother Raymond McIntosh PWGP, Facebook Administrator indicated that he can advertise the Shopfront on Facebook.

- ◆ The amount of \$400 to be paid to the Supplies Refurbishment Account.
- ◆ The Reports on Supplies from all the State Delegates indicated that the clothing items were not selling. Jewellery from USA was popular. \$2,000 was transferred to the Supplies Parked Fund Account in case funds were required to purchase more jewellery.
- ♦ Chapter Treasurers may use their own Payment Voucher but they must also use the UGCA Payment Voucher. It was reconfirmed that the Payment Voucher would have three signatures and cheques have two signatures.
- ◆ Three PMWGP jewels are to be ordered and quotations will be obtained from John Newton Jeweller and Somers & Son.
- ◆ The donation to the MWGM and MWGP Charity, I CAN Network, was \$6,900.
- ♦ A Funeral Service for Non-sectarian Members was approved and will be added to the Chapter Ritual.
- ◆ The Webmaster and Facebook Administrator are to be invited to attend the Mid Term Session in Hobart in June 2020 and the United Grand Committee Meeting at the commencement of the 2021 Biennial Session. A Notice of Motion will be submitted at the 2021 Biennial Session for Law U.29 to be amended in order for the compilation of the United Grand Committee to include the Webmaster, Facebook Administrator, Assistant to the Worthy Grand Secretary, Assistant to the Worthy Grand Treasurer, Assistant to the Worthy Grand Organist and Assistant to the Worthy Grand Supplies Officer.
- It was agreed that so long as it is recorded in the Minutes of the Meeting that the Sentinel has been invited into the Chapter Room and also recorded that the Worthy Matron has asked the Sentinel to retire before the Closing Ceremony, it is quite in order for the Sentinel to take part in the business of the meeting by moving and seconding items of business.
- ♦ Any Member who needs to submit a Report to the Biennial Session or the Mid-Term Session should do so by forwarding same to the Worthy Grand Secretary ten days prior to the commencement of the appropriate Session.
- ♦ It was agreed that it should be recorded that the Present and Past Grand Representatives' Association is part of the structure of The United Grand Chapter of Australia.
- ♦ The venue for the 2021 Biennial Session in Sydney will be the Bankstown Sports Events Centre, 8 Greenfield Parade, Bankstown.

◆ Term Deposits

No. 191781 for \$11,423.08 was reinvested at 2.15% and will mature again on 27 November 2019. When this term deposit matured it was found that the change of signatories submitted to Westpac Bank by the Worthy Grand Treasurer had not been updated by the Bank and arrangements were made for this to be rectified.

No. 191812 for \$9,708.37 at 2.05% will mature on 11 September 2019.

These amounts will be re-invested at the best possible interest rate available at the time of maturity.

♦ Fees

The \$3 Dispensation Fee will no longer be payable.

A \$10 per annum fee will be payable for Outreach Membership.

The \$5 document fee for the email version of Minutes will be re-instated in 2021. Members who have paid the \$30 fee for the printed version of the Minutes can notify the Worthy Grand Secretary if they wish the email version and arrangements will be made for them to receive the Minutes by email but the overpayment of \$25 will not be reimbursed.

It was requested that consideration of the administration costs of \$120 for District Grand Committees be reduced as these Committees did not have the same opportunity to raise funds. Advice was given that the District Grand Committees could raise funds by having social events, requesting payments from Chapters or that the Members pay for Minutes.

It was also requested that there be a reduction in the insurance payments. It was explained that the insurance was a blanket policy under the Grand Lodge of New South Wales and that no changes could be made to the calculation of payments by the various Chapters and other organisations such as Rainbow Girls and White Shrine.

♦ Bye-Laws

It was agreed that the Allegiance Clause may be placed at the beginning or at the end of all Chapter Bye-Laws including Home Fund and Home Management Bye-Laws covered by The United Grand Chapter of Australia.

Chapters are to have the Allegiance Clause in their Bye-Laws and if they do not currently have the Clause in their Bye-Laws, they should attend to this when making the next amendment to their Bye-Laws. The relevant Allegiance Clause is:

All Members of the Grand Chapter of *[District Grand Committee] *[Chapter No.] shall abide by the Constitution, Laws, rulings, instructions and directions of The United Grand Chapter of Australia.
